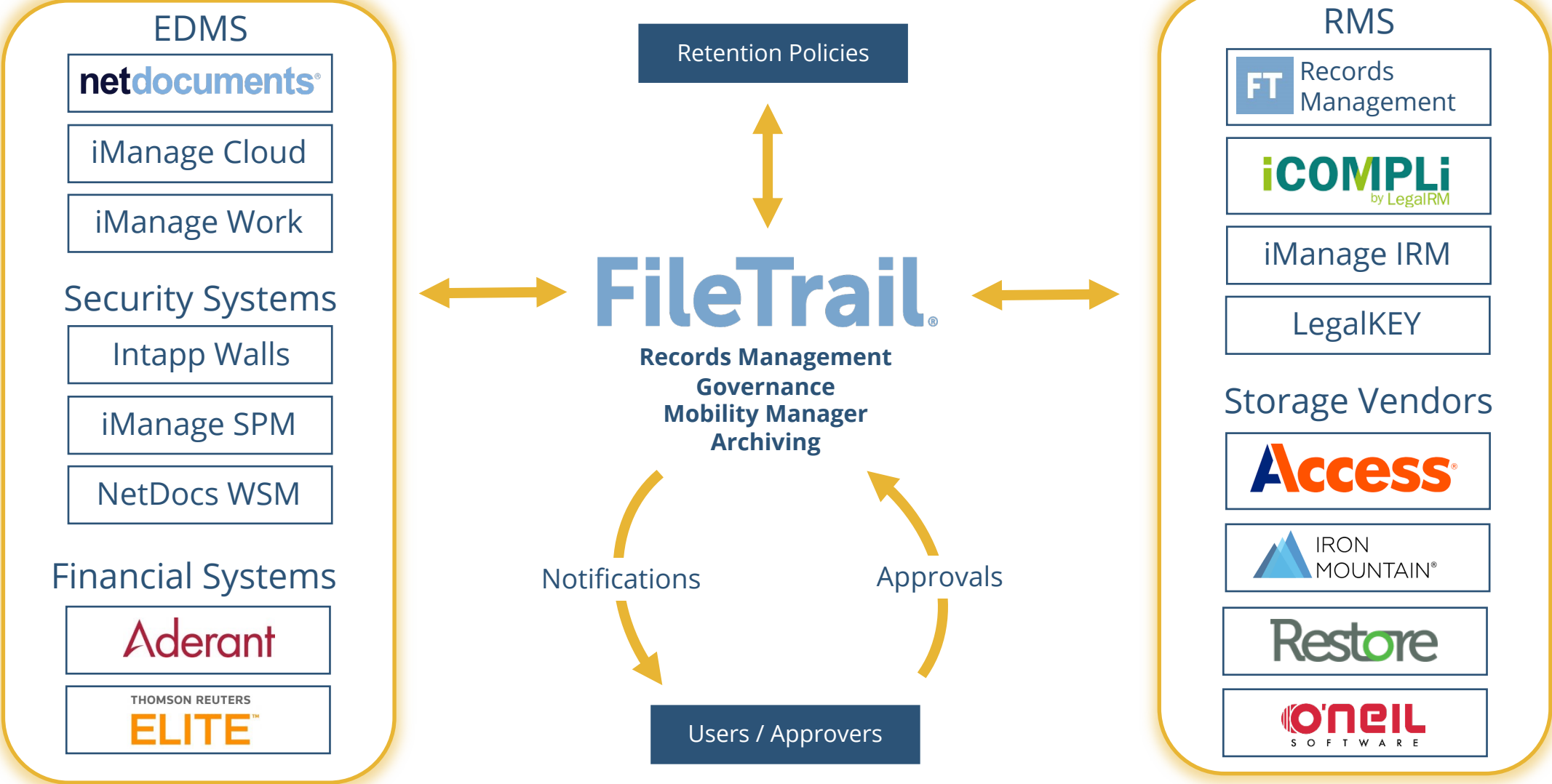

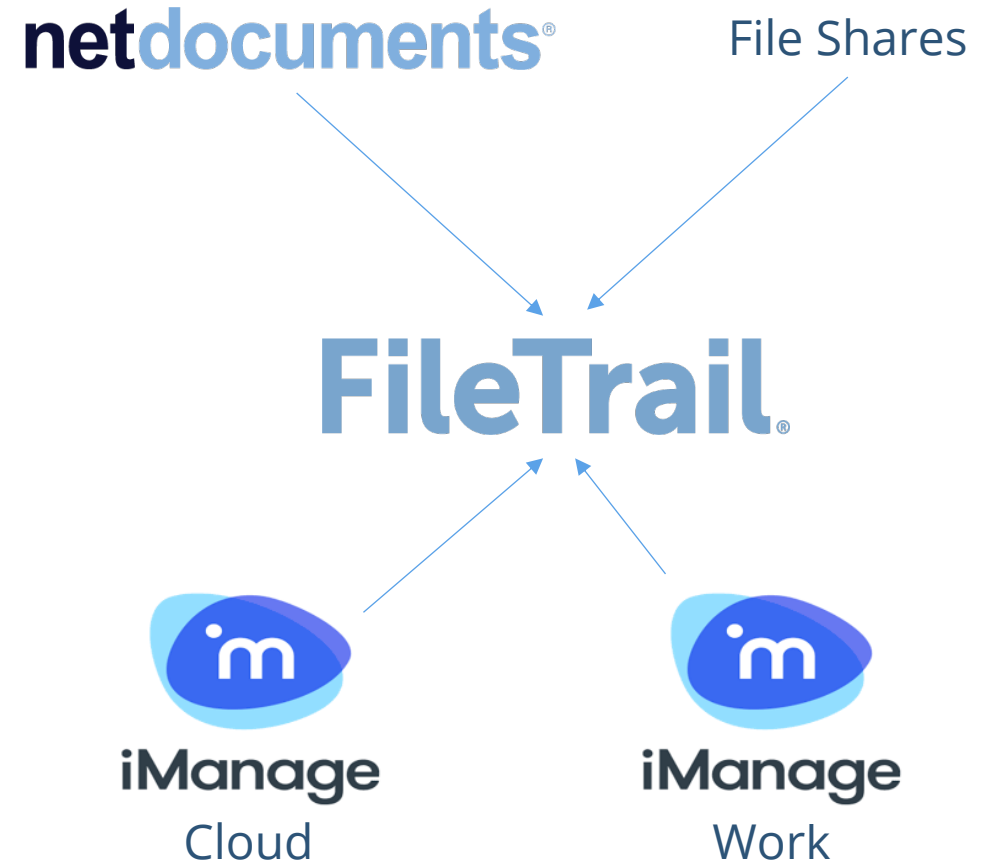

Integration with Document Repositories

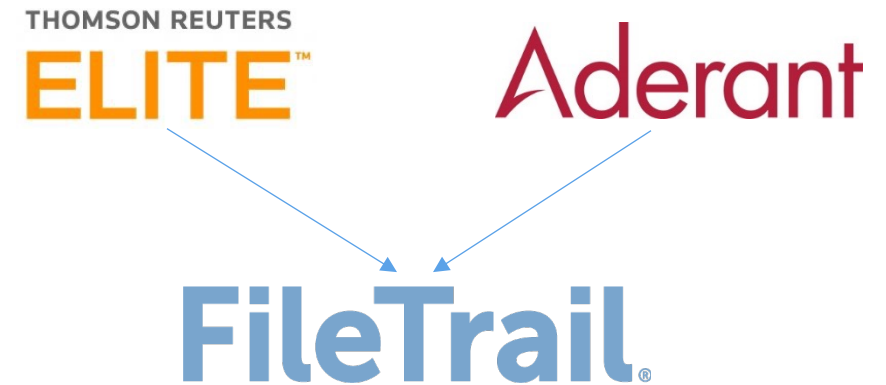
- Repository integration provides visibility to documents in the FileTrail UI, and allows these documents to participate in any of the inherent FileTrail functionality, such as disposition review, disposition, searching, reporting, and more.
- FileTrail supports integration with a number of repositories and are continually adding support for additional repositories to meet the needs of markets.
- FileTrail also supports integration with other RM systems, should you choose not to utilize FileTrail Records Management.

Integration with Financial Systems

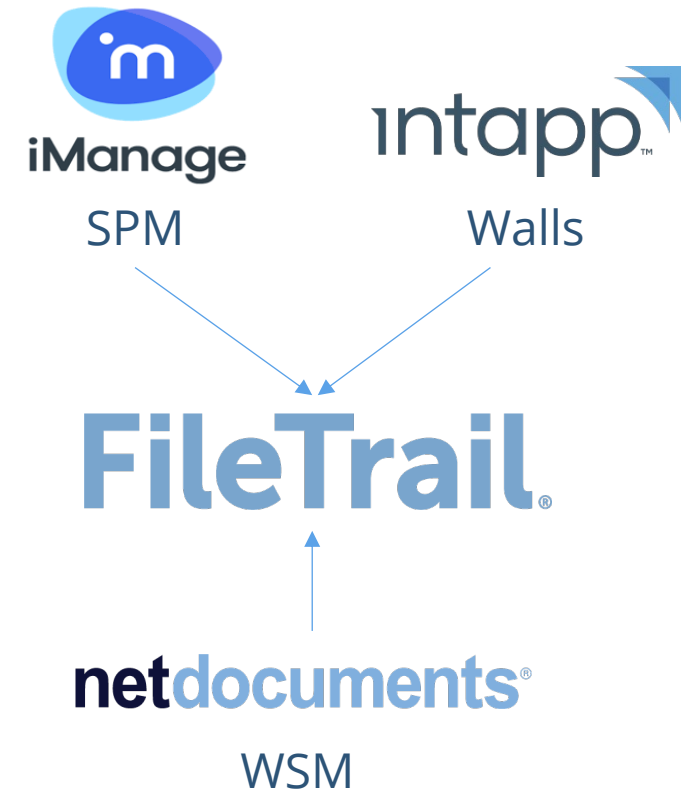
- Integration with financial systems creates new Clients and Matters and synchronizes updates.
- FileTrail's unlimited user-defined fields allows you to additionally synchronize other data that is not widely available to everyone, and can be leveraged in FileTrail processes, searching, and reporting. Law firms frequently choose to populate the Matter Profile with:
 - Timekeepers – leverage with one-click emails for quick communication.
 - Terms – store terms, or outside counsel guidelines, for easy reference.
 - Last Billing Date – use with searching to identify matters that may need to be officially closed.



Technology that Integrates

Integration with Security Systems

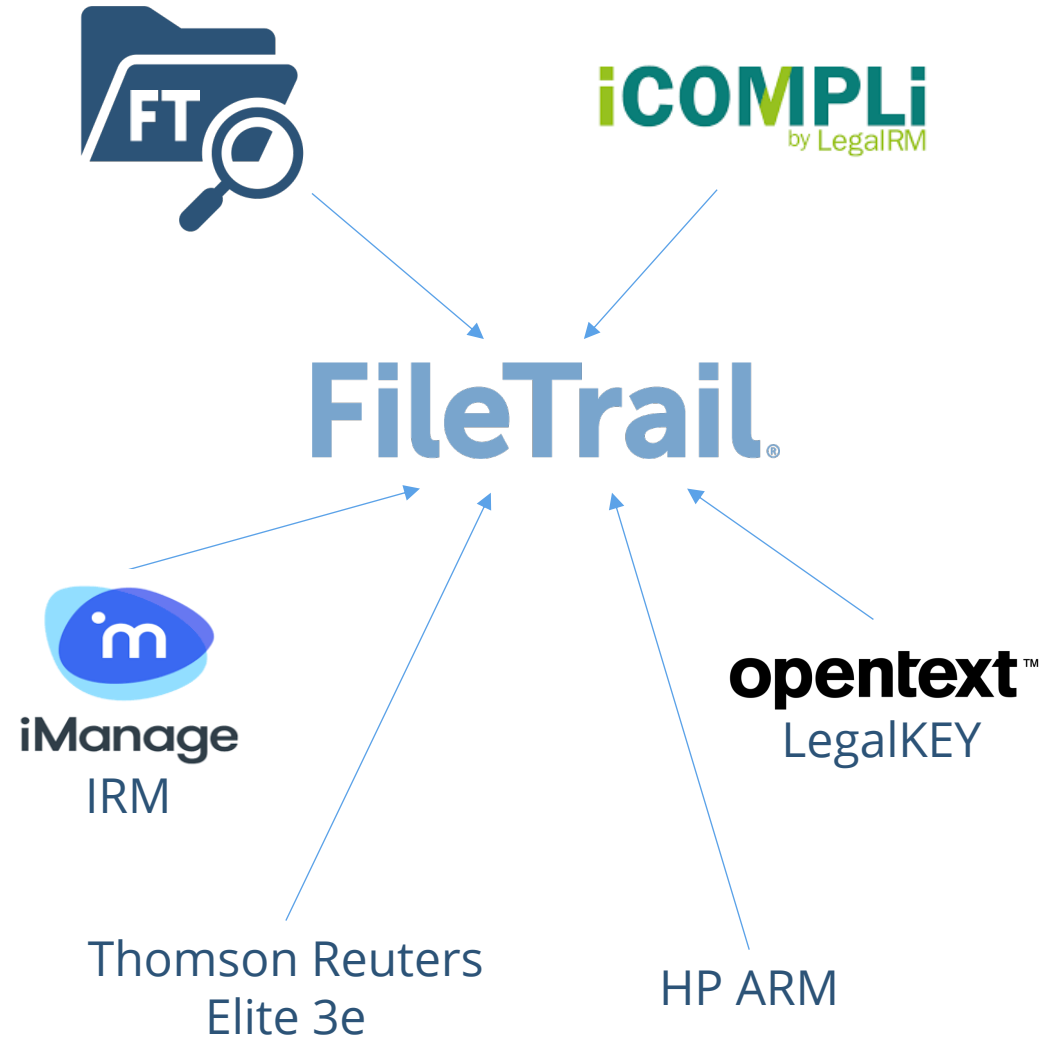
- Integration with security provision systems ensures the conflicts policies are up-to-date and applied to matters, records, and documents in FileTrail.
- FileTrail support optimistic and pessimistic models, as well as Contractor walls. Security policies created at the client level are automatically inherited down to matters. All security policies are inherited down to any electronic documents, boxes, expandos, folders and subfolders.
- Changes to policies are automatically reflected in FileTrail, without user intervention.
- FileTrail provides visualization of the security results, allow an administrator to see the rights on a client or matter, or on a record or document that have been inherited from the client or matter policy.



Technology that Integrates

Integration with Records Management Systems

- RMS integration provides visibility to physical records withing the FileTrail UI for clients who choose to stay with their existing RMS.
- This integration allows these records to participate in inherent FileTrail functionality, such as disposition review, disposition, searching, reporting, and more.
- FileTrail pushes destruction requests for records back the RMS. Core RMS functions – such as creation, labeling, requesting, and interfacing with storage vendors – are still performed within the RMS.



Technology that Integrates

Integration With Archival Storage Vendors

- FileTrail is partnered with Access Corp. Our seamless integration provides real-time ordering for retrieval of archived records, ordering pickup of new and returning boxes for storage, and digital retrieval (aka Scan-On-Demand). Leveraging real-time Web Services, FileTrail and Access deliver the most efficient management and handling of inactive physical records.
- FileTrail has also been providing clients with integration to Iron Mountain since 2002.
- We are currently creating integration for Records Centers using O'Neil Software, and to Restore in the UK.

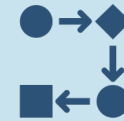

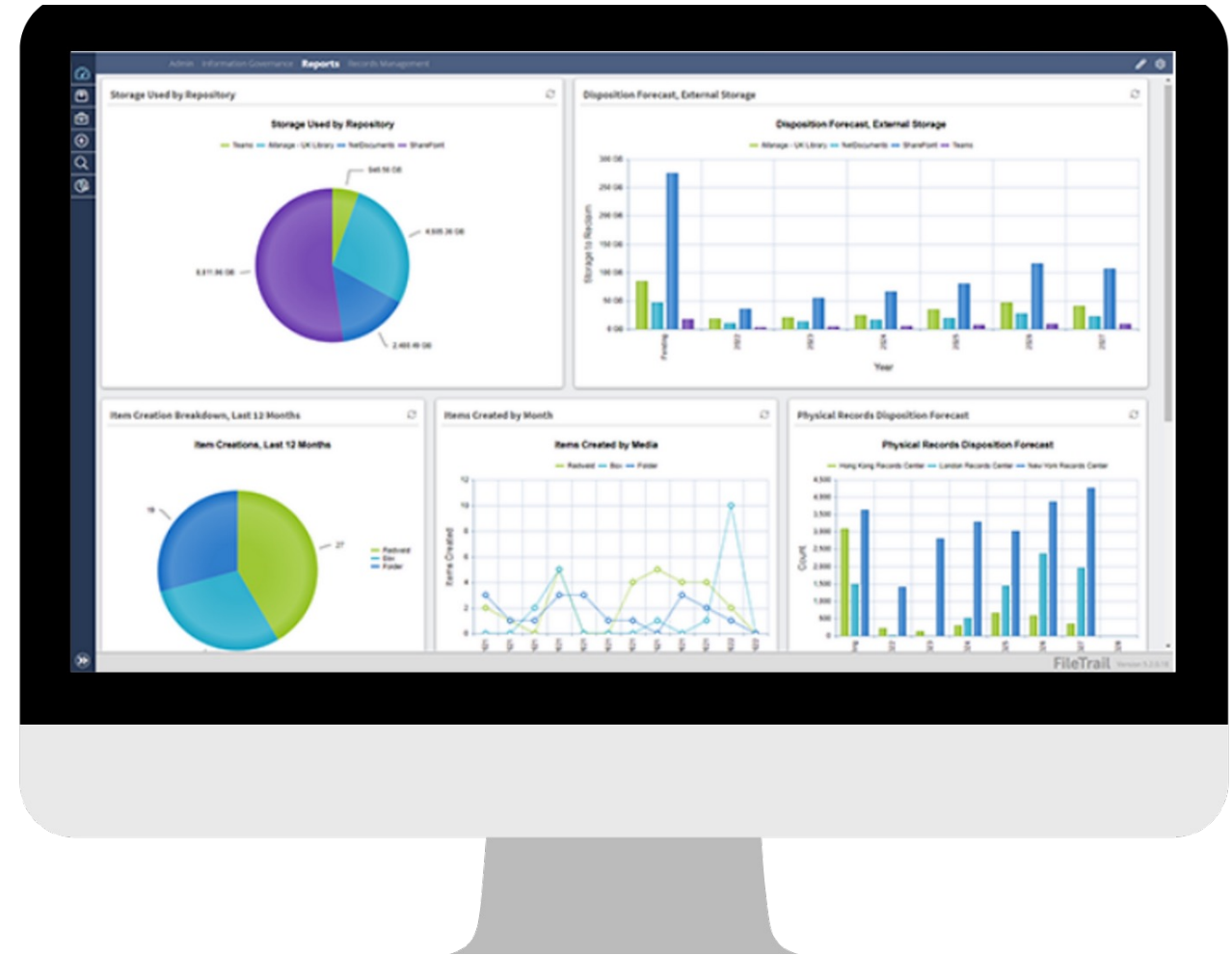

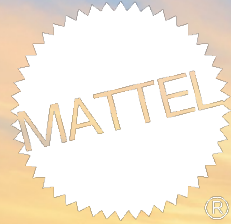
